Ingredients

Mentofin® is a 100% natural mix of peppermint and eucalyptus essential oils.

The menthol generated by the peppermint essential oil helps to create a refreshing 'cooling' atmospheric effect which in turn facilitates breathing.

The eucalyptol or 1.8-cineol from the eucalyptus essential oil is commonly used to alleviate respiratory symptoms.

How to use Mentofin®



IN DRINKING WATER

Use Mentofin® at 200ml in 1000L of water in the water trough or dosing pump.

For better homogeneity of the mix, add 200ml of Mentofin® in 10L of lukewarm water, then add this solution to 1000L of water, and stir thoroughly until the solution is fully dissolved.



AERIAL APPLICATION: MISTING

For a floor surface of 1000m², (equating to 3500m³) use 200ml of Mentofin® in 10L of water once or twice per week.

Repeat the application until the desired result is achieved.

Recommended form of use

Mix in livestock drinking water or apply as an aerial application by misting or fogging.

Instructions for Use

Application	Dosage	Duration
General Prevention	Drinking water 200ml per 1000L of water Misting / Fogging 200ml per 10L of water	For 3 to 4 days
Specific Prevention Alleviation of post-vaccination reactions	Drinking water 200ml per 1000L of water	2 days after vaccination for 3 days
Respiratory problems at the end of the production cycle	Drinking water 200ml per 1000L of water	3 days per week for the last 2 weeks of the cycle
Heat stress	Misting / Fogging 200ml per 10L of water	3 days per week for the last 2 weeks of the cycle

Precautions

Always monitor water consumption when Mentofin® is administered in drinking water.

Do not apply Mentofin® 2 days before or after administration of a live vaccine, either by spray or drinking water applications.

Do not mix Mentofin® solution with antibiotics, other additives or substances, either by spray or drinking water applications.

As young turkeys are very sensitive, do not administer to turkeys in the first 20 days of life due to a potential decrease of water intake.

Storage

Stable 3 years sealed in the original container. Do not store below +10° C. Keep away from direct sunlight.
