## **SECTION 4: First-aid measures**

#### Description of first aid measures:

**General:** If irritation or other symptoms occur or persist from any route of exposure, remove the affected individual from the area: see a physician/get medical attention.

# **SECTION 5: Fire-fighting measures**

#### Extinguishing media:

# SECTION 7: Handling and storage

Store this material away from incompatible substances (see section 10). Do not store in open, unlabeled or mislabeled containers. Keep container closed when not in use. Do not reuse empty container without commercial cleaning or reconditioning. Empty container contains residual product which may exhibit hazards of product.
